- Handover of the vehicle in Kenya, ready for collection.

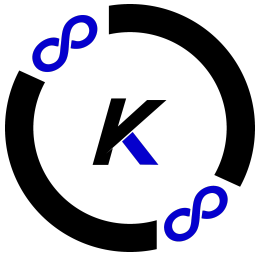
3. PAYMENT STRUCTURE (TRANSPARENT)
